- 1) May 15 – Serving: Cancellation requests received prior to May 8 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received May 8 – May 13 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received May 14 or later will not receive a refund.
- 2) May 16 – Passing/Defense: Cancellation requests received prior to May 9 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received May 9 – May 14 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received May 15 or later will not receive a refund.
- 3) May 21 – Outside Hitter/Setter: Cancellation requests received prior to May 14 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received May 14 – May 19 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received May 19 or later will not receive a refund.
- 4) May 22 – Attacking/Blocking: Cancellation requests received prior to May 15 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received May 15 – May 20 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received May 20 or later will not receive a refund.
- 5) May 23 – Serving: Cancellation requests received prior to May 16 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received May 16 – May 21 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received May 21 or later will not receive a refund.
- 6) June 17 – Serving: Cancellation requests received prior to June 10 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 10 – June 14 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 15 or later will not receive a refund.
- 7) June 18 – Middle Hitter/Setter: Cancellation requests received prior to June 11 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 11 – June 15 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 16 or later will not receive a refund.
- 8) June 19 – Passing/Defense: Cancellation requests received prior to June 11 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 11 – June 16 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 17 or later will not receive a refund.

- 9) June 20 – Outside Hitter/Setter: Cancellation requests received prior to June 12 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 12 – June 17 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 18 or later will not receive a refund.
- 10) June 24 – Attacking/Blocking: Cancellation requests received prior to June 16 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 16 – June 21 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 22 or later will not receive a refund.
- 11) June 25 – Passing/Defense: Cancellation requests received prior to June 17 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 17 – June 22 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 23 or later will not receive a refund.
- 12) June 26 – Serving: Cancellation requests received prior to June 18 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 18 – June 23 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 24 or later will not receive a refund.
- 13) June 27 – Attacking/Blocking: Cancellation requests received prior to June 19 are eligible to receive a full refund minus a \$10 administrative fee. Cancellation requests received June 19 – June 24 are eligible to receive a full refund minus a \$30 administrative fee. Cancellation requests received June 25 or later will not receive a refund.
